Eastern Monmouth County Chamber of Commerce Presentation

Best Practices

Mr. DeBlasio explained what 'Best Practices' is and the history behind it. He noted that any municipality which scores below 75% the State can withhold aid. He stated that Highlands scored 87% and added that the Borough is constantly working to improve. Councilmember Braswell asked for an example of some of the things that are asked witch Mr. DeBlasio provided.

Administrator's Report

Ms. Gonzales discussed updated the Council on the Valley Street project and reviewed various other projects including Monmouth Hills drainage, Jones Creek bulk head & installation of valves. Ms. Gonzales noted that she is looking into grant opportunities to get higher bulk heads. The Mayor and Council discussed ways they are looking to improve the flooding and sewer problems in the Borough. Ms. Gonzales reviewed pending grants, commented that the budget is currently being worked, and discussed the road schedule. She also explained Resolution 232 was to look into any Shared Service possibilities with Sea Bright. Ms. Gonzales noted that the closing on the property for the new Borough Hall was scheduled for November 19th 2018.

Police Chief's Report

Chief Burton provided an explanation as to why the police officers are all growing beards, noting it is to bring awareness to men's health in addition to a fundraiser to buy Christmas gifts for needy families.

Engineer's Report

Mr. Herrmann discussed the replacement of the Shore Drive pump and as well as concerns which are being worked on. He updated the public on the electric for Veteran's Park, the Police Department trailer sanitary sewer connection, and the Sanitary Sewer CBGB project. Mr. Herrman noted that FEMA will be hearing challenges to the flood maps and explained his concerns with Borough's maps.

Kim Gonzales suggested to discuss at next meeting giving the opportunity to the Mayor and Council to review.

Public Comments

Carol Bucco, Shore Drive, asked the Mayor to please remember that Captain's Cove flooded for the next hearing.

Kim Skorka, Shore Drive, questioned why Captain's Cove was not raising their bulk head. Mayor O'Neil stated that he didn't believe that it was a requirement. Ms. Skorka questioned who asked for Shore Drive parking lot to be paved. Mayor O'Neil explained that he had. Ms. Skorka expressed concerns over flooding with the paving of the lot and the safety issue of residents not being able to drive through the lot to get to Shore Drive when the road is flooded. Mayor and Council discussed with Ms. Skorka concerns over the parking lot. Councilmember Braswell stated that the Mayor and Council is taking the flooding seriously and are making major strides towards correcting the problem.

Mike Patton, Central Avenue, requested to have two spots which would allow residents to cut through the lot in the case of flooding marked as "no parking" in the Shore Drive parking lot. He explained how this is a safety issue for residents during flooding. Councilmember Braswell stated that the bulk head will be replaced and that it has been requested to keep the parking spots open. Mr. Patton asked if the bulk head at Veteran's Park is to be raised. Mayor O'Neil explained the process that it would have to undergo to get that project completed. Mr. Patton Mike raised concerns of over the Captain's Cove bulk

head elevation and the possible redevelopment. Councilmember Broullon discussed these concerns with Mr. Patton.
