## **HEARINGS ON NEW BUSINESS:**

LUB2020-06, 1-3 Barberie Ave., Block 77 Lot 13, Gil -Subdivision

Board Attorney swore in Mr. Paul Gil and Robert Davis. Mr. Gil explained that he's asking to subdivide his L-shaped lot into smaller lots to build two residential homes. Mr. Davis is a developer. He partnered with Mr. Gil to buy the property that had been vacant since Irene. The lot is larger than surrounding lots and the existing structure is a multifamily building. With the subdivision, they're looking to demolish the existing multifamily to build two new single-family buildings instead. They are also seeking some variances too. Mr. Herrman gave an overview of the different variances that the applicant is seeking. He also explained the required variances vs. the proposed variances.

Exhibit A-1 was entered. The proposed subdivided lot sizes are comparable to surrounding lot sizes. They proposed removing a nonconforming multifamily to two single-family. The positive and negative points were given. Christian Lee wanted to add that appropriate landscaping with permeable surfaces will be considered that is consistent with the neighborhood.

Applicant is seeking subdivision with building envelope. Once subdivision is approved, they will then design the structure.

Three residents, including Tricia Rivera, within the 200-yard list voiced support for the application and applicant.
