Chairman Stockton recused himself due to a conflict. Vice Chairman Knox stepped in.

Attorney Baxter read list of exhibits.

Attorney Baxter swore in Mr. Jesse Beim 13 Marine Place Highlands NJ 07732.

Vice Chairman Knox asked Mr. Beim for a brief description of what his plan is.

Mr. Beim stated home is fairly dated needing many updates. The cost of these updates would be almost as much as tearing down and rebuilding new. The main reason he is coming before the board is to be able to keep the tree in his backyard.

Attorney Baxter asked if the tree Mr. Biem is speaking of is the only tree in the backyard. Mr. Beim stated there is a smaller tree but the tree he is referring to is the larger one.

Mr. Lee questioned the parking situation would there be enough. Mr. Beim stated yes there is enough room and that he would also be utilizing the garage for parking vehicles.

Attorney Baxter discussed the variances that were required.

Mr. Beim testified that there were no accessory features or structures, etc. that would need relief that were not listed on plans.

Attorney Baxter swore in Mr. Anthony Condouris 20 Bingham Ave Rumson NJ licensed architect.

Mr. Condouris stated that there was no plan on the placement of the air conditioning unit at this time but they would conform to whatever is needed.

Chief Burton asked what side the electrical service came into the house and would the electrical panel be accessible to JCP&L or would another deck be needed.

Mr. Beim explained the service and meter is on right side of the house and the panel would be put on the desk for easy access.

Mr. Lee asked if there was any testimony on the positive and negative criteria.

Mr. Condouris stated the house is being built almost exactly as it is now and is relatively modest. It is a good fit to the neighborhood. There will be no detriment to the neighborhood.

Vice Chairman Knox opened the meeting for any questions or comments from the public on this application.

Attorney Baxter swore in Mr. Peter Mullen 11 Marine Place. Mr. Mullen stated he is quite pleased with the proposed home. He did ask that the architect confirm that there will be two spots for parking that would not impede sidewalk. He also asked that the electrical service comments be clarified.

Mr. Condouris and Mr. Beim both confirmed that the electrical service would come in from Huddy Avenue. Mr. Beim also stated the parking will remain the same and does not impede the sidewalk as is. There is also going to be parking underneath the house.

Vice Chairman asked if there were any further other question or comments from public or board members. Seeing none he asked if anyone would offer a motion.

Mayor Broullon offered a motion to approve.

Councilmember Mazzola seconded.

Attorney Baxter added the conditions that were in Mr. Herman's letter and that the tree remain unless unhealthy or becomes a public hazard to become part of the motion. No further comments.
