This Sustainable Jersey action can be used by a municipality to fulfill components of the 2021 amendment (S-2607) to New Jersey's Municipal Land Use Law (MLUL) that requires a climate change-related hazard vulnerability assessment when updating the land use element of their Master Plan.

Sustainable Jersey is working with support from the New Jersey Department of Environmental Protection (NJDEP) to provide short-term guidance on how to use Sustainable Jersey actions, like this one, to advance climate resilience planning, adaptation, and emergency preparedness. Please refer to <u>Sustainable Jersey's</u> Interim Resilience Planning Guidance for more detail and see the updated resources section of the action.

As part of a larger effort, Sustainable Jersey is actively working with NJDEP, New Jersey Future, Rutgers University, ANJEC, the Urban Coast Institute, and additional partners to update actions and develop more detailed guidance to emphasize climate resilience planning as a foundation principle of environmental stewardship and sustainability.

This action assists municipalities, like Highlands, in painting a full picture of diversity in their community by creating a simple demographic and spatial profile, with a focus on identifying residents who are socially vulnerable or who have special communication needs. This action further guides municipalities to investigate, on the one hand, the barriers to communication that these social groups experience, and on the other, the communication channels and social networks they prefer and rely upon to obtain trusted information and to express needs and opinions. Municipalities can put this information and enhanced understanding to use to support more equitable communications, public engagement, and resource allocation.

Through its work with Sustainable Jersey, the Highlands Green Team has gathered the following data and prepared this report for the Borough Council and the Land Use Board.

Notes on statistics presented here:

- The majority of the Community Profile data is from the 2015 and 2020 US Census American Community Survey (ACS) 5-year estimates data. The ACS is an ongoing survey administered by the US Census Bureau that provides updated data every year. The 5-year estimates are "period" estimates that represent data collected over five years. Sustainable Jersey refers to the period by the year it came out (e.g. 2020 is 2016-2020 and 2015 is 2010-2015). ACS data is best compared five years apart. - Municipal Revitalization Index (MRI) data is from New Jersey Department of Community Affairs
- Commercial & Industrial Properties data is from Department of the Treasury Division of Taxation's Property Tax List (MOD IV) data (https://www.arcgis.com/home/item.html?id=102a9bf3c6da4ca3b9b31f831a1e9f72)

Definitions

% Hispanic or Latino Origin - Refers to a person of Cuban, Mexican, Puerto Rican, South or Central American, or other Spanish culture or origin regardless of race.

Low and Moderate Income (LMI) - According to The US Federal Reserve and other federal and state agencies, a low- and moderate-income community earns less than 80% of median household income. New Jersey's median household Income based on 2020 ACS data was \$85,245. Therefore, an LMI municipality is a municipality with a median household income below \$68,196.

Municipal Revitalization Index (MRI) Distress Score and Rank - The MRI, developed by New Jersey Department of Community Affairs (NJ DCA), scores and ranks New Jersey's municipalities according to eight separate indicators that measure diverse aspects of social, economic, physical, and fiscal conditions in each locality.

- MRI score has a 1 to 100 range. 100 is most distressed; 0 is least distresses.
- <u>MRI score</u> of 50-75 denotes a moderately distressed municipality; <u>MRI score of 75-100</u> denotes a highly distressed.
- MRI rank shows the municipalities in order based on rank: 1 is most distressed, 565 is least distressed. For more information about the MRI, visit: https://www.nj.gov/dca/home/MuniRevitIndex.html MRI data is not available for 2015 and 2020, so available data from the closest years was used instead. The 2015 sheet contains MRI data from 2017, and the 2020 sheet contains MRI data from 2019.

Total Housing Units - Housing units can be single-family homes or apartments.

<**75% Occupied** - If less than 75% of housing units are occupied, a municipality is likely seasonal, a country club, or there are very few people living there. Some of the data for these municipalities is not reliable because the Census collects data from people's primary residences.

Units by Year Structure Built - Shows the number of housing units in a community built between certain years.

¹ A further breakdown of racial categories (e.g., American Indian or Alaska Native, two or more races) would be informative – if the municipality is of sufficient population for statistical accuracy (see Technical Note above).

² Based on the U.S. Census, "ethnicity" refers to "Hispanic or Latino origin," by which is meant a person of Central or South American, Caribbean, Puerto Rican "or other Spanish culture or origin regardless of race." This means people who are Hispanic may be of any race.

³ The labor force includes all adults working or seeking work. It does not include, for example, students without jobs or retirees. Unemployment figures may under-represent economic hardship, because they do not include those who have given up seeking work, those who are involuntarily employed part-time, or people with disabilities that prevent them from working.

Paramount is making all communications [English-Spanish] bi-lingual. 

















ALICE - an acronym for Asset Limited, Income Constrained, Employed (ALICE), represents the growing number of individuals and families who are working, but are unable to afford the basic necessities of housing, child care, food, transportation, energy, and health care. Highlands ALICE households are between 500 – 1,000 according to the 2020 Census.
