## RESOLUTION 24-165

**AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT FOR  
PROFESSIONAL SERVICES IN CONNECTION WITH THE HIGHLANDS TIDE VALVE  
INSTALLATION PROJECT**

**WHEREAS**, the Borough of Highlands has a need for professional services in connection with the Highlands Tide Valve Installation Project pursuant to N.J.S.A. 19:44A-20.5; and

**WHEREAS**, Colliers Engineering & Design, Inc. has set forth its proposed services in a written proposal dated August 8, 2024, a copy of which is available at the office of the Borough Clerk; and

**WHEREAS**, the scope of work for the aforesaid project includes the installation of Tide Valves located at North Street and Shrewsbury Avenue, Valley Street and 5<sup>th</sup> Street and Snug Harbor Outfall; and

**WHEREAS**, Colliers Engineering & Design will prepare construction plans for the aforesaid project as well as the supplemental and technical specifications for the site improvement items, estimate of quantities and construction details; and

**WHEREAS**, the said proposed services includes the following lump sum fee:



**NOW, THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Highlands as follows:


