Borough Updates for September:

- Shadowlawn AINR Continuing negotiations for Developer's Agreement.
- Captain's Cove AINR A prospective redeveloper has expressed interest but has not yet submitted plans.
- Bay Avenue AINR –289 Bay Developer's Agreement completed.
- Regionalization to include Sea Bright The 3 Mayors met on 8/29 to discuss nest steps.
- Emergency Services Incidents: First Aid Squad = 35; Fire = 30; Police =
- Code Enforcement Summons = 2; Warnings = 7; Reports = 20; Inspections = 24; Permits = 15; OPRA = 11
- Building Department Inspections = 41; Passed = 30; Failed = 7; Not Ready = 4; Permits issued = 18

Current Project Updates- Weather Permitting

- Marine PI Elevated Walkway East [Sea Drift] -Started ADA 6/12 should be complete by the end of Sept.
- Shore Drive Pedestrian Safety Improvements Completed 7/2, 4 trees planted on Central Ave 9/22.
- Frank Hall Park Updates & Overlook Park Creation MCOS \$86,000 FHP & OP MCOS \$148k + DCA \$74k. Work started 9/20. Majority of the work to be done in Sept Nov.
- North Street NJ American Water will be installing a new water main starting 10/1.
- VFW Parking Lot Mill & paved on 9/15.
- Shore Drive Re-lined all striping from Bay Ave to Willow St, completed 9/29.

Grants won – projects to be permitted & awarded

- Linden, WW, Bay & Snug Harbor Drainage Improvements Estimated \$1.7 Million project to on these roads \$1.3 Million from NJDOT Local Aid Grant. Waiting for DEP Letter of Support of the project to go out to bid.
- Grand Tour Drainage Improvements Project estimate \$1 million, Grant \$217,456. Work moved to 2026.
- County Open Space Won \$225,050 Resurface playgrounds at Vets, Huddy and Rec, also fix courts at Snug.

Grants submitted waiting to hear back

- CDBG 7/2025 New Sidewalks on 36 from Linden to Waterwitch & Waterwitch from 36 to Linden around HES.
- Safe Roads to Transit 7/2025 New sidewalks on 36 from Waterwitch to Valley Ave.
- **REPI Living Shoreline & Bulkhead Design & Permitting** US DOD grant of \$219,676 for design, permits are approved by DEP & Army Corps. Implementation grants to be announced early 2026.

Grants being explored

- Sanitary Sewer Phase II NJ Water Bank, USDA Water & Waste & other options being explored.
- Overpass Walkway over R36 Looking to resubmit for funding with State & County options.
- **Flood mitigation & Green Infrastructure** Project = \$16,205,280. We were waiting for comments from the State Historic Preservation Office. BRIC cancelled by E.O. on 4/18/25. In review with FEMA Environmental.
- New First Ad Building Possible Congressionally Directed Spending, also looking at modular solutions.
- New Pumper Truck for FD Put seed money in this year's budget & exploring grant options for purchase.
- **Bronze Huddy Statute** The proposed installation will be located at Huddy Park, just 150 feet from where he was hanged in 1782. We are looking for County & State grants.

Community Rating System [CRS] Update

The CRS Certification process continues as we work with property owners in the flood zone to build resiliently.
