## **RESOLUTION 26-015**

### **AUTHORIZING AWARD OF A FAIR AND OPEN CONTRACT FOR PROFESSIONAL SERVICES – CONFLICT ATTORNEYS**

**WHEREAS**, the Borough of Highlands has a need for professional conflict attorney legal services for the calendar year 2026 pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

**WHEREAS**, such professional services can only be provided by licensed professionals and the firms of Maraziti Falcon, LLP, Marmero Law LLC, and Peri Stewart Malia are so recognized; and

**WHEREAS**, the Borough has reviewed all proposals received and has determined that the Mayor and Borough Council desire to authorize the execution of professional services contracts between the following listed persons/firms and the Borough for the provision of said services for the year 2026; and

**WHEREAS**, the Chief Financial Officer has determined and certified in writing that the value of the contract will exceed \$17,500; and

**WHEREAS**, certification of availability of funds has been provided by the Chief Financial Officer contingent upon the adoption of the 2026 budget.

**NOW THEREFORE BE IT RESOLVED**, by the Borough of Highlands Council as follows:

1. That the firm of Maraziti Falcon, LLP is hereby appointed and retained to provide professional conflict attorney services at an hourly rate of \$195.00 per hour, for the twelve (12) month period beginning January 1, 2026, through December 31, 2026, in an amount not to exceed \$26,000.00.
2. That the firm of Marmero Law, LLC is hereby appointed and retained to provide professional conflict attorney services at an hourly rate of \$150.00 per hour, for the twelve (12) month period beginning January 1, 2026, through December 31, 2026, in an amount not to exceed \$26,000.00.
3. That the firm of Peri Stewart Malia is hereby appointed and retained to provide professional conflict attorney services at an hourly rate of \$185.00 per hour, for the twelve (12) month period beginning January 1, 2026, through December 31, 2026, in an amount not to exceed \$26,000.00.
4. The Mayor and Municipal Clerk are hereby authorized to sign the contracts for the aforesaid professional services.


5. These contracts are awarded without competitive bidding as “Professional Services” in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-5(1)(A)(i) because it is for services performed by persons authorized by law to practice a recognized profession.

7. The Municipal Clerk is hereby directed to publish public notice of this award as required by law.
