The person who circulates the petition shall not be required to be a registered voter, but shall be voter eligible, which means at least 18 years of age, a resident of this State, a citizen of the United States, and not otherwise disqualified under the New Jersey Constitution. The witness may sign one set of signatures endorsing the candidate. Note that if the witness/circulator is not a qualified voter of this political subdivision for which the candidates stand for office, then he/she is permitted to circulate said petition but is not permitted to sign as a petitioner.

## BALLOT DRAWING WAIVER

Due to a legislative change, two or more candidates seeking the same office for the same length of term who file either a joint or singular petitions with the intent of associating can request to be grouped on the Primary Election ballot and be drawn together, instead of individually, for purposes of determining ballot position within an office block. **Pursuant to N.J.S.A.19:23-18, candidates who intend to associate must affirmatively waive their right to be drawn individually for ballot position if the candidates wish to be drawn together as a group** inside the ballot block. Candidates filing petitions that have not completed this waiver will be drawn individually for purposes of determining ballot position.

## BALLOT DRAWING WAIVER

# PETITION FILING INSTRUCTIONS FOR COUNTY COMMITTEE

## WHEN AND WHERE TO FILE:

Petitions must be filed with your **Municipal Clerk, on or before 4:00pm, 71 days before the date of the Primary Election.** The timelines for the Primary and General elections can be found on the County Clerks's website, <https://www.monmouthcountyvotes.com/elections/election-timelines/> or on <https://njelections.org/>. Please be advised timelines are subject to change as new laws are enacted.

## NUMBER OF SIGNATURES:

Contact your Municipal Clerk to obtain the minimum number of petition signatures required. **To be eligible to sign, a signer MUST be from the same political party or unaffiliated, and be a resident and registered voter of the political subdivision to which the office pertains.** Contact information for your Municipal Clerk can be found on our website: <https://www.monmouthcountyvotes.com/contact/municipal-clerks/>.

## HOW TO COMPLETE A PETITION:

1. Read the Petition carefully and fill in all blank spaces where required.
2. Page 2, fill out where indicated: the name of the municipality, election district #, political party (Democratic or Republican), candidate's name, candidate's residential address, and a functioning campaign email address for each candidate.
3. On signature pages, place the candidate's name, the title of office, and election district #.
4. All signers must print their names and residence address and affix their signatures.
5. *Affidavit of Person Who Circulates This Petition and Witnesses Signatures.* The witness taking the affidavit must be the person who solicited and obtained that set of signatures for the petition. That witness must take the affidavit for each set of signatures solicited and sign the affidavit in the presence of a person authorized to administer affidavits, such as a notary. The person who administers the affidavit cannot be the candidate. Please review petition packet for the full list of qualifications required to be a circulator/witness of the petition. The candidate can be the witness/circulator and there can be more than one circulator for each petition.
6. *Oath of Allegiance and Certificate of Acceptance.* Each candidate only needs to fill out and sign said *oath* and *certificate* **once**. The *Oath of Allegiance* must be signed in the presence of a person authorized to administer affidavits. The person who administers the affidavit cannot be the candidate.
7. *Candidates' Request for Designation.* Fill out where indicated on this page: the name of the municipality, candidate's name, candidate's signature, office, and designation/slogan.
8. *Ballot Drawing Waiver.* Candidates running for the same office and same length of term who intend to associate must affirmatively waive their right to be drawn individually for ballot position if they wish to be grouped together inside the ballot block. If you wish to group or associate with other candidates on the ballot, fill out where indicated and check the box to waive your right to be drawn individually.
