AUTHORIZING AWARD OF FAIR AND OPEN CONTRACT FOR AUTO AND TRUCK REPAIR SERVICES

WHEREAS, the Borough of Highlands accepted bids on June 16, 2026 at 10:00 a.m. for repair services for the Borough's automobiles and trucks for the period of July 1, 2026 through June 30, 2027; and

WHEREAS, one (1) bid was received for the aforesaid repair services for the Borough's automobiles and trucks which was reviewed by the Borough Administrator's Office, as follows:

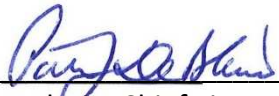

WHEREAS, the Borough Administrator has made the recommendation that the contract be awarded to Sea Bright Service Center LLC, 75 Bay Avenue, Highlands, New Jersey, 07732, in the hourly amounts listed above, for an amount not to exceed \$50,000.00, subject to the availability of funds by the Chief Financial Officer of the Borough of Highlands; and

WHEREAS, a certification of funds is hereby provided by the Chief Financial Officer of the Borough of Highlands.

That the Contract for repair services for the Borough's automobiles and trucks, for the period of July 1, 2026 through June 30, 2027, is hereby awarded to Sea Bright Service Center LLC in the amount of \$95.00 per hour for vehicles up to 1 ton and \$175.00 per hour for vehicles over 1 ton, for an amount not to exceed \$50,000.00.

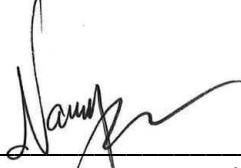
