AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT FOR PROFESSIONAL SERVICES – SANITARY SEWER MAP UPDATE SERVICES

WHEREAS, the Borough of Highlands has a need for professional services related to updating the Borough's Sanitary Sewer Geographic Information System ("GIS") Map pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, Colliers Engineering and Design, Inc. has submitted a written proposal dated June 25, 2026, for Sanitary Sewer Map Update Services, a copy of which is available at the office of the Borough Clerk; and

WHEREAS, said professional services includes digitization of the Borough's master sanitary sewer map, filling in system gaps as identified on the master map, field collection and GIS training for Borough personnel; and

WHEREAS, the proposed amount of the contract with Colliers Engineering and Design, Inc. is \$20,000.00; and

WHEREAS, such professional services can only be provided by licensed professionals and the firm of Colliers Engineering and Design, Inc., 101 Crawfords Corner Road, Suite 3400 Holmdel, New Jersey 07733 is so recognized; and

WHEREAS, the governing body has determined that it is in the best interest of the Borough to retain Colliers Engineering and Design, Inc. for the aforesaid professional services related to the Borough's Sanitary Sewer Map Update Project, as set forth in its proposal; and

WHEREAS, this contract is to be awarded for an amount not to exceed \$20,000.00 for professional services as stated in Colliers Engineering and Design, Inc.'s proposal dated June 25, 2026; and

WHEREAS, Colliers Engineering and Design has completed and submitted a Business Entity Disclosure Certification which certifies that it has not made any reportable contributions to a political or candidate committee in the Borough of Highlands in the previous one year and that the contract will prohibit Colliers Engineering and Design, Inc. from making any reportable contributions through the term of the contract; and

WHEREAS, Colliers Engineering and Design has completed and submitted a Political Contribution Disclosure form in accordance with P.L. 2005, c 271; and

WHEREAS, certification of availability of funds is hereby provided by the Chief Financial Officer of the Borough of Highlands;

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Highlands as follows:

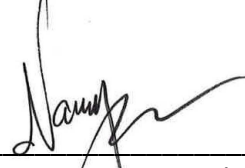

2. The contract is awarded without competitive bidding as a "Professional Service" in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-5(1)(a)(i). The Mayor and Borough Clerk are hereby authorized to sign said contract.
3. A copy of the Resolution as well as the contract shall be placed on file with the Borough Clerk of the Borough of Highlands.
4. The Borough Clerk is hereby directed to publish notice of this award as required by law.
