RESOLUTION 26-159

AUTHORIZING THE AWARD OF A NON-FAIR AND OPEN CONTRACT FOR PROFESSIONAL SERVICES – STORMWATER MS4 MAP UPDATES

WHEREAS, the Borough of Highlands has a need for professional services in connection with updating the Borough's stormwater GIS data for the generation of the MS4 Infrastructure Map, pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, Colliers Engineering and Design, Inc. has submitted a written proposal dated June 25, 2026, a copy of which is available at the office of the Borough Clerk; and

WHEREAS, said professional services include reviewing the Borough's existing MS4 infrastructure data, identifying any new additions to the stormwater system since the original stormwater mapping project in 2022, flagging, reviewing and updating mapping where feasible using available GIS and as-built data as well as field verification; and

WHEREAS, the scope of work includes updating and modifying the Borough's stormwater system mapping, wherein the Borough's MS4 Infrastructure Map and MS4 stormwater data will be provided to the New Jersey Department of Environmental Protection ("DEP") for approval as outlined in the 2023 NJDEP MS4 Tier A Stormwater Permit; and

WHEREAS, the proposed amount of the contract with Colliers Engineering and Design, Inc., which consists of Field Data Review and Verification and MS4 Map Preparation and NJDEP Submission is in the amount of \$16,300.00; and

WHEREAS, such professional services can only be provided by licensed professionals and the firm of Colliers Engineering and Design, Inc., 101 Crawford's Corner Road, Suite 3400, Holmdel, New Jersey 07733 is so recognized; and

WHEREAS, the governing body has determined that it is in the best interest of the Borough to retain Colliers Engineering and Design, Inc. for the aforesaid professional services related to the Borough's Stormwater MS4 Map Updates as set forth in its proposal; and

WHEREAS, this contract is to be awarded for an amount not to exceed \$16,300.00 for professional services as stated in Colliers Engineering and Design, Inc.'s proposal dated June 25, 2026; and

WHEREAS, Colliers Engineering and Design, Inc. has completed and submitted a Business Entity Disclosure Certification which certifies that it has not made any reportable contributions to a political or candidate committee in the Borough of Highlands in the previous one year and that

the contract will prohibit Colliers Engineering and Design, Inc. from making any reportable contributions through the term of the contract; and

WHEREAS, Colliers Engineering and Design, Inc. has completed and submitted a Political Contribution Disclosure form in accordance with P.L. 2005, c 271; and

WHEREAS, certification of availability of funds is hereby provided by the Chief Financial Officer of the Borough of Highlands;

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Highlands as follows:

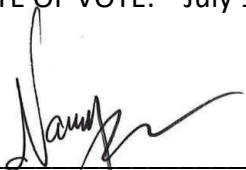
