AUTHORIZING THE PURCHASE OF AN E-ONE TYPHOON RETAIL PUMPER THROUGH THE SOURCEWELL COOPERATIVE PURCHASING PROGRAM

WHEREAS, pursuant to N.J.S.A. 52:34-6.2(b)(3), the Borough may by resolution and without advertising for bids, purchase any goods or services using a nationally recognized and accepted cooperative purchasing agreement that has been developed utilizing a competitive bidding process by another contracting unit; and

WHEREAS, the Borough of Highlands has a need to purchase one (1) E-One Typhoon Retail Pumper, Unit 147522, for the Highlands Fire Department through Sourcewell Contract, E-One No. 082025-RVG, from Absolute Fire Protection Co., Inc.; and

WHEREAS, Absolute Fire Protection Co., Inc., with offices located at 2800 Hamilton Boulevard, South Plainfield, NJ 07080, is an authorized vendor under Sourcewell Contract, E-One No. 082025-RVG; and

WHEREAS, Absolute Fire Protection Co., Inc. has submitted a proposal dated June 10, 2026 for one (1) E-One Typhoon Retail Pumper, Unit 147522 in the amount of \$721,939.00; and

WHEREAS, certification of availability of funds is hereby provided by the Chief Financial Officer of the Borough of Highlands, contingent upon the effective date of Bond Ordinance O-26-17, adopted August 19, 2026.

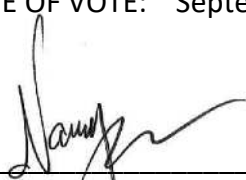
